

## Fourth Quarter Board Meeting



## Christmas Party & Awards Banquet

December 10th



#### Welcome - Class of 1999!



Okay, I know what you're thinking. 1999??? That was like...well...25 years ago. So why is 1999 being mentioned in a vintage car club newsletter? Because, believe it or not, cars from 1999 now qualify as vintage cars by VMCCA rules.

But those are just used cars right? If you're my age maybe...but to a younger generation they're cool. So here's to the young folks joining the VMCCA. Go out and find a clean, well maintained 1999 something-orrather, and join the club! Or perhaps even save something that interests you from the crusher.

A couple of points to consider: In the 1920s, GM President Alfred P. Sloan implemented a policy of yearly styling updates, a practice adopted from the fashion industry. This meant that customers could tell if a car was old or new...a sort of "planned obsolescence". In the 1930s as streamlining became the rage, styling changed rapidly and by the 1950s annual styling changes had the nation captivated each fall as the next year's new designs were unveiled.


That began to wane in the early 1970s as the cost of major design changes seemed less and less necessary. So by 1999, a new model being introduced would remain mostly unchanged...at least visually for many years. When new designs ARE issued, they typically aren't that dramatically different from what came before.

Secondly, back-in-the-day cars didn't last very long unless they were very well cared for and driven sparingly. My 1st "woods car", a 1960 Chevrolet Biscayne was so rusty by the time it was 10 years old that I bought it for \$25. Newer cars just don't rust like that. Even the paint can still look good 20 years on. In those days it was also an amazing event when a car "rolled over"...that is when the odometer went from 99999 to 00000. Not many cars made it that far...and if they did they probably blew a lot of blue smoke. People today typically drive a lot more miles...BUT the newer cars can easily go two to three times the distance...and with minimal care.

The result of all this is that cars 10, 20, even 25 years old are still in daily service. Certainly that has changed our perception of what a vintage car is. Maybe at some point the rules will change but for now... welcome Class of 1999.

Several years back, not that long ago, I bought a flat-screen television. They had just come on the market and they were very expensive at the time. I gladly laid down over \$2,000 for mine to have one of these marvels in my living room. Of course, you can now get a flat-screen TV for much, much less. I actually saw a 65-inch flat-screen TV at Walmart recently for under \$400. Go figure.

I have had another similar experience with my car. When the ceramic waxes first hit the market only shops with "trained" technicians could apply it properly. Again, I paid over \$2,000 for a nice ceramic wax to be applied to my wife's car. They kept the car all day to apply the ceramic coating. The results came out great.



And wouldn't you know it, I see now (again years later) that anybody can buy ceramic waxes right off the shelves at a host of stores for about \$20. Go figure again.

So, what's the deal with all these ceramic waxes being produced by numerous companies, and what makes them so special and why are they now so cheap? I will tell you why.

This is not a case where the product became less expensive over time like TV's, but rather, the product concentration is commensurate with the price. This happens when any product is "watered down" and it then becomes cheaper to buy. But, hey, that's not necessarily a bad thing.

The ceramic wax products on the market generally do a good job. And, they certainly are easy to apply. All you have to do is spread it on and wipe it off with a microfiber cloth. I use \$20 ceramic waxes all the time with good results.

When I paid a shop to apply a ceramic wax to my wife's car, they used a very concentrated formula that required a special applicator to apply it to the paint surface. In addition to microfiber cloths, they used mechanical buffers to bring the shine to a lustrous finish. The ceramic was also applied to the windows and chrome which were also buffed to a sparkling shine.

So why can't anybody just use the special concentrated ceramic wax. You can! However, instead of it only costing \$20 for a 16 ounce bottle, the four ounce concentrated bottle may cost you up to a hundred dollars (again, depending on the concentration). Most high end auto product stores sell it both ways. To name one company, Chemical Guys has both concentrations and they also have the applicators and buffers for the concentrated wax.

The high end automotive shops claim that the brilliant shop-applied shine will lasts for months, if not for years. However they also sell you a bottle of the \$20 ceramic solution to "refresh" the shine every so often.

Unless you are in the car detailing business I would stick to the \$20 ceramic wax kits. To me, the results are undistinguishable.
